





20 MILLIONTH VISITOR AT CANADA LIFE CENTRE CONTEST

Official Contest Rules & Regulations

By entering the 20th Millionth Visitor (the "Contest"), entrants agree to abide by these Official Contest Rules and Regulations (the "Contest Rules") and the decisions of True North Sports & Entertainment Limited and the Winnipeg Jets Hockey Club (collectively referred to herein as the "Sponsors") which are final and binding in all respects relating to the Contest. Eligible Entrants (as defined herein) agree to abide by these Official Contest Rules and Regulations (the "Contest Rules") and the decisions of the Sponsors which are final and binding in all respects relating to the Contest.

1. CONTEST PERIOD

The Contest period begins at 9 a.m. (CST) on October 16, 2024 and closes at 5 p.m. (CST) October 18, 2024 (the "Contest Period").

2. HOW TO ENTER

There is no purchase necessary to enter the Contest. Enter using one of these methods of entry: (a) enter Canada Life Centre on October 18th, 2024 via a valid ticket for the Winnipeg Jets vs. San Jose Sharks hockey game; or (b) send a 500 word essay to media@tnse.com telling us why you love attending events at Canada Life Centre (essay must be completed unaided by artificial intelligence). No entries will be accepted by any other means.

3. ELIGIBILITY

Unless otherwise specified, the Contest is open only to individuals who: (i) are a resident of Manitoba and (ii) are eighteen (18) years of age or older at the time of entry (each an "Eligible Entrant"), unless otherwise noted. The Sponsors have the right to require proof of eligibility from any individual who enters the Contest. Failure to provide such proof may result in disqualification from the Contest.

The employees, agents, or representatives of True North or of any entity involved in the sponsorship, development, production, implementation and distribution of any Contest (collectively the "Excluded Individuals"), including their respective agents, affiliates, subsidiaries, related companies, sponsors, advertising or promotional agencies, or assignees, and their immediate family members, are prohibited from participating in the Contest and do not qualify. - One-of-a-kind 20 millionth fan Winnipeg Jets jersey.

Approximate value for the Prize: \$2,500.00. The Prize must be accepted as awarded and may not be traded, sold, assigned, transferred, converted to cash or substituted, except in the sole discretion of the Sponsors. The Sponsors, in their sole discretion, reserve the right to substitute the Prize in whole or in part in the event that all or any of the components of the Prize is unavailable.

In the event that the Prize winner is unable to redeem any or all of the Prize due to reasons beyond the control of the Sponsors or if in the event the Sponsors are unable to offer any or all of the Prize components due to reason beyond their control, no compensation or substitute prize will be awarded.

5. <u>SELECTION OF WINNER</u>

The potential Prize winner will be selected via random draw of any Eligible Entrants attending the Winnipeg Jets game on October 18, 2024 (also included in the draw will be those that entered via the alternative form of entry). The Sponsors will advise the potential winner in one of two ways: (a) via email (the "Notification E-mail") if the potential winner entered via the alternative method or (b) in person at the game on October 18, 2024.

If advised via email, the Eligible Entrant selected as potential winner shall have two (2) hours to: (i) communicate their acceptance of Prize; (ii) correctly answer, unaided, a time limited, mathematical skilltesting question; and (iii) execute and return to the Sponsors the Acknowledgement of Contest Rules form.

If advised in person, the Eligible Entrant selected as potential winner must (i) correctly answer, unaided, a time limited, mathematical skill-testing question; and (ii) execute and return to the Sponsors the Acknowledgement of Contest Rules form.

If the Eligible Entrant fulfills the requirements above, they will be the Prize winner.
